
QUESTION

"SHALL THE ORDER AUTHORIZING \$11,280,000 GENERAL OBLIGATION BONDS OF DURHAM COUNTY, NORTH CAROLINA FOR THE PURPOSE OF PROVIDING FUNDS, WITH ANY OTHER AVAILABLE FUNDS, TO PAY CAPITAL COSTS OF CONSTRUCTING A STADIUM, DESIGNED FOR BASEBALL AND OTHER PUBLIC EVENTS, NECESSARY PARKING, ACCESS AND RELATED FACILITIES, AND THE ACQUISITION OF ANY NECESSARY LAND, RIGHTS-OF-WAY AND EQUIPMENT, AND AUTHORIZING THE ENTERING INTO OF STADIUM LEASES OR USE AGREEMENTS WITH THE DURHAM BULLS OR OTHER PROFESSIONAL BASEBALL TEAM OR FOR OTHER PUBLIC EVENTS, AND AUTHORIZING THE LEVY OF TAXES IN AN AMOUNT SUFFICIENT, AFTER THE APPLICATION OF AVAILABLE REVENUES FROM LEASE OR USE OF THE STADIUM, TO PAY THE PRINCIPAL OF AND THE INTEREST ON SAID BONDS, BE APPROVED?"
